Kenneth Fish Right Choice Led To Fascinating Life

Adversity tests and confirms our character. We choose to let it make us bitter, or we can strive to rise above our circumstances. Kenneth Fish made the right choice and led a fascinating life in the process.

Kenneth Fish, former owner of the First National Bank of Homer, knew adversity. One of the youngest of the children of Guy and Lydia Fish of Bloomington, IN, he was born on June 9, 1919, in Sidney, IL. The family later moved back to Indiana. Kenneth was about ten or eleven years old when his mother died following surgery. His youngest sibling was only six weeks old. Kenneth's dad not only lost his wife; because of the Depression he also lost his job as a stonecutter, his home and his car.

Guy Fish looked for people to take in his children and help raise them. Kenneth Fish spent time with his grandparents in Bedford, IN, and with other relatives. He and his older brother, Wally, took on a paper route, using their earnings to buy a pair of bicycles costing three dollars each. With about two dollars in cash between them, they set out on their bicycles for Homer, IL, where an aunt, Ida Penny, lived. She had lost her own son. On their trip they sustained themselves with fruit from apple and peach orchards, and some people along the way fed them sandwiches. Eventually Wally returned to Indiana. Kenneth decided to stay in Homer.

He took a room in the former Christian Rest Home, which is now a private residence at Ellen and South Streets, and found work doing odd jobs to buy books for high school. Kenneth lived with a foster family in Urbana for several years while going to Urbana High

School. He returned to Homer for his last two years of high school and lived with Mr. and Mrs. Tudor. During his junior year, he spent 30 days in the hospital due to a ruptured appendix. Ida Penny paid all his medical bills.

Mr. Kemp Catlett, president of the Homer bank, noticed Kenneth's diligence at his work, and hired him as janitor for the bank. Among his jobs there he was responsible for stoking the coal furnace.

J.W. and Nell Tudor, owners of the drug store, hired Kenneth to work for them starting at 4 p.m. each day, when Kenneth was done at the bank. After the store closed at 6 p.m., Kenneth would go to Harold Hayes' Standard Oil station and restaurant on Main Street, pumping gas and washing dishes until midnight. Kenneth ate his evening meal there.

Kenneth needed a new suit for his high school graduation. His aunt Ida bought him one for ten dollars from (no relation) Harriet Fish's clothing store in Danville. It was, as he said, a good, good suit at the time. And the clothing store Mr. Fish always treated them well.

Following Kenneth's high school graduation, Mr. Catlett offered him a choice. He would send Kenneth to college for two years, or teach him the banking business. Kenneth chose the latter. He made a dollar a day, plus what he made at the drug store and the restaurant. It was enough to get by.

During the depression, people didn't have money to go to movie theaters. Instead, someone would set up a movie screen outdoors and show free movies. While at Patterson Springs to see a movie, Kenneth was introduced to Gladyne, daughter of farmer George Hopper. Kenneth asked Gladyne for a date, and they went roller-skating at the rink in Muncie on Saturday evening and on many other occasions. Kenneth and Gladyne were married on September 23, 1939, at her parent's home. Her uncle, a minister in Bethany, IL, officiated. They spent their honeymoon at her Aunt Roxy Kelly's in Cincinnati. Gladyne left her \$12 a week job, and they lived on Kenneth's \$15 a week income.

After working five years at the bank, and needing more income, Kenneth left to work for Standard Oil of Decatur. He worked at different times and in various locations as a driver and as an agent. World War II interrupted his employment there, and he went into the Navy. But because of color blindness, he couldn't see action. He spent the entire 21 months and five days of his career in the Navy at Great Lakes Naval Station.

Following the war, several banks tried to hire Kenneth, knowing that he had banking experience, but Mr. Catlett advised him against it, hinting that something better would be coming along for him.

Finally, Mr. Catlett offered Kenneth the insurance agency. He would be a partner with Les Krugh. So he worked for Standard Oil by day and sold insurance at night.

That continued until Les Krugh died. Mr. Catlett wanted to bring Kenneth into the bank at that time, but he didn't want to give up his Standard Oil income. So Mr. Catlett offered him better money. In time Kenneth was made a director and bought ten shares of stock.

He and Mr. Catlett took many trips together, fishing out west in places such as the Wind River Indian Reservation: Salmon, ID and the River of No Return. Kemp Catlett knew their traveling days would end when he hired Kenneth, because one of them would always need to be at the bank. Later, as a banker Kenneth attended many bankers' conventions and would take side trips following most conventions.

In 1980, he bought controlling interest in the bank upon the death of Mr. Catlett. Over the course of sev-

eral months in about 1986, his son, Jim, bought the insurance agency and became president of the bank, and Mr. Fish became the chairman of the board. However, he still came in to work every day until his health began to fail in the early 1990's.

Mr. Fish served on many community organizations. For example, he was the president of the Homer Lions Club, a member of the American Legion and secretary/ treasurer of the Homer School Board. Because he had received so much help himself, he gave generously to others who were in need.

Kenneth and Gladyne moved into their newly built home, bought from a divorcing couple for \$8000, in about 1956. The mantle of the fireplace was cut by his dad, and hauled here from Indiana. Kenneth died on June 25, 1995. Gladyne lives there still with her apricot poodle companion, Buffy.

The Fishes have two children, Judy Johnson and Jim Fish, and four granddaughters. A grandson is deceased.

Homer News From The Past

The Homer Enterprise Thursday, February 3, 1938 page one Oldest Business in Homer Sold

Tudor Drug Store bought by W.H. Kook and W.F. Link
Tuesday morning of this week the Tudor Drug
Store, as such, ceased to be, the ownership passing to
the business firm of Kook and Link of Paris, IL. The
new business of the firm are W.H. Kook and W.F. Link,
who operate Rexall Drug Stores at Paris, Newman,
Casey and Homer. The business at Paris is the home
store. Under the present arrangement J.W. Tudor, former owner, will help in the store, with either Kook or
Link devoting several hours each day to the business
here.

Kenneth Fish will continue clerking in the evening hours. Changes in interior arrangements are being added from time to time. To most people of this community the change came as a complete surprise, though it had been under consideration for some time. In the passing of the Tudor Drug Store, Homer loses its senior business firm in point of continued service. L.L. Hamill, who owns and operates the variety store, has been in business longer but not in his present line of business.

The founder of the Tudor Store was the late John A. Tudor, who started in the business in November, 1881. Upon his death in January, 1931, the business was continued until this week by his son.

The senior Tudor came to Homer in 1874 and began his drug store training under the late Dr. White in the building now occupied by Edna McElwee's beauty shop. He continued to clerk for the late Dr. James Core, father of the late Mrs. C.H. Wallace, who succeeded Dr. White, and who in turn was succeeded by O.J. Tinkham.

In 1881 Mr. Tudor left Tinkham's employ to go into business for himself in the building now occupied by the Hedrick Barber shop and in 1881 built and moved into the brick building which now houses the firm of Kook and Link, although a fire in 1890 destroyed the interior and contents.

A card appears in this issue of the Enterprise in which Mr. and Mrs. Tudor convey to the people an expression of appreciation for its loyalty to them. Had the public a medium through which it might voice such an expression to Mr. and Mrs. Tudor for their efficient service of the past years it is quite probable it would be unanimously ordered.

"Cookies from the Past" MAE SLAYTON'S BANANA OATMEAL COOKIES

1 c. sugar

2/3 c. shortening

2 eggs

1/2 tsp. vanilla

1/2 tsp. lemon extract

3/4 c. mashed bananas

1 1/2 c. quick cooking oatmeal

2 c. flour

3/4 tsp. soda

1 tsp. baking powder

1/2 tsp. salt

1/2 c. chopped nuts

Cream sugar and shortening. Add eggs. Beat till light and fluffy. Blend in flavorings, mashed bananas and rolled oats. Sift dry ingredients together and blend into creamed mixture. Stir in nuts. Drop by tablespoons onto an oiled cookie sheet. Bake at 350 degrees for 15-18 min.

MABEL RUTAN'S TWICE BAKED COOKIES

1/2 c. butter

1/2 c. brown sugar

1/4 tsp. salt

1 c. flour

Mix together, using pastry blender. Spread evenly in greased 9x13 pan. Bake 15 min. at 325. While this bakes, blend together:

2 eggs, well beaten

1/2 tsp. baking powder

1 c. chopped nuts

1 tsp. vanilla

1 c. brown sugar

2 Tblsp. flour

1 1/2 c. coconut

Spread on baked mixture and bake 25 min. more. Cut into squares while still warm.
